# Are you working?

The answer to this is Yes and No. We are all capable of working from home, but this depends on the type of work that you have been hired to do.

If we have been provided with a work laptop, we can still do our work. Depending on what you do you may need to connect to work servers which requires you to have a VPN account, which mean that you are logging into work securely.

Work with your manager to understand what your current work priorities should be.

# Should I go into the office?

The answer to this was noted in an email sent, on Thursday April 2, 2020, from the Office of the Secretary of the Cabinet, below has been extracted from the memo.

As I outlined in my memo on March 24, we are currently delivering services remotely. Only OPS employees that are required to deliver critical services will be asked to come to work in person. I am writing today to confirm this will continue until at least May 1, 2020. Closer to May 1, we will re-evaluate this decision based on public health advice.

However, if you are required to deliver critical services, discuss this in detail with your manager. Management has a general duty to take every reasonable precaution to ensure that you are safe.
